- 2. Principals' submissions re: impact of consolidating districts (Frank)
 - a. Agreed to incorporate principals' perspectives into Streamline Committee's work, including communication leading up to March 2017 vote on warrant articles
- 3. Strategic Draft Overview (Mike)
 - a. Committee discussed draft proposal to develop a SAU-wide Strategic Overview. Discussion included the content of the strategic overview and approaches to complete the SAU-wide Strategic Overview in time to support the School Boards' December discussions and decisions re: language of Warrant Articles that will recommend consolidation of school districts.
